Approval may be granted to remove a street tree provided that the owner and applicant comply with other provisions of this Code. Street tree removal permits shall be subject to the requirements of Section 16.142.060.B. Street trees that are removed must be replaced by the owner/ applicant unless the City of Sherwood has authorized a replacement tree per section 16.142.060.D.

Trees under 5" DBH do not require a permit; however replacement is required per section 16.142.060.B of the Sherwood Zoning and Community Development Code.

All trees over 5" DBH (Diameter at Breast Height) require a 10 calendar-day street tree removal sign posting. All trees over 10" DBH (Diameter at Breast Height) require an arborist report describing the condition of the and why the tree must be removed.

All trees proposed for removal shall be posted by a sign provided by the City, adjacent to the tree for 10 calendar days.

Tree Replacement Exemption

A street tree that was planted in compliance with the Code in effect on the date planted and no longer required by spacing standards of section §16142.A.4 may be removed without replacement provided:

1. Exemption is granted at the time of street tree removal permit or authorized homeowner's association removal per Section §16.142.060.C.
2. The property owner provides a letter from a certified arborist stating that the tree must be removed due to a reason identified in the tree removal criteria listed in Section §16.142.060.B.1, and
3. The letter from a certified arborist describes why the tree cannot be replaced without causing continued or additional damage to public or private utilities that could not be prevented through reasonable maintenance.

- I will replace the street tree(s) within six (6) months of the date of removal at my expense.
